### E-LEARNING MODULES PROGRAM





### **Grant description**

The Australian Multicultural Foundation (AMF), on behalf of SEAN-CSO, will support and coordinate the development of two e-learning tools in partnership with members across the SEAN-CSO network. The two e-learning tools will be based on secondary/tertiary CVEinterventions must provide shared and applicable learnings to members across South-East Asia and be informed by consultation with governments and communities.

The AMF would like to invite SEAN-CSO members to a workshop on Tuesday 9 August 2022 at 3:00 p.m. (AEST) to discuss a second round of seeding grants to assist in the development of secondary/tertiary intervention ideas to inform two new interactive e-learning modules. To be eligible to apply for this grant, you need to attend this workshop. The AMF on behalf of SEAN-CSO will be offering five seeding grants to the value of AUD \$2000 to develop ideas and content for the e-learning modules.

The AMF will work closely with the applicants of the successful submissions towards the development of these e-learning tools.

To support the development of your submission, please see below the following criteria, for your consideration.

## E-learning concept selection and application guidelines:

Applications for the e-learning seed funding grant will open on **Tuesday 9 August 2022** and will close on **Monday 22 August 2022 at 5:00 p.m.** (AEST).

To apply, organisations must submit a '**concept brief**' that is no longer than 500 words including the following:

	Questions to address	Proposal
1	details of the secondary/tertiary intervention concept	
2	evidence that the concept has been informed by consultation with the government and the community and how the proposed concept will meet the needs of these stakeholders	

3	a clear target audience and purpose of the concept (i.e: is this a training concept or is it a concept that demonstrates the outcomes of a model or program?)	
4	how the concept will be transferable and applicable for all CSOs in the SEAN-CSO network.

### What is an e-learning module?

An e-learning module is a learning tool that can be accessed online and includes digitally presented information on a specific topic, interactive learning and assessment elements such as multiple choice activities and case studies.

The AMF and SEAN-CSO have previously developed e-learning modules such as the Community Awareness Training. This module is a key example of what e-learning tools are and how they work. The structure of the new e-learning modules will be dictated by the ideas presented in the application process. We will be looking for ideas that are innovative and lead to an interactive learning experience.



# What are secondary/tertiary CVE interventions and what concepts are we looking for?

CVE programs are typically framed analogously to public health programs: secondary interventions with at-risk individuals and groups, often youth, and tertiary interventions designed to heal and rehabilitate.

Some examples of these interventions can include:

- initiatives targeting individuals or groups "at risk"
- initiatives targeting convicted or former extremists
- · initiatives targeting families of former extremists,
- tools that aims to support the implementation of other initiatives in the region (e.g. assessment, screening tools)
- targeted training to raise the quality of secondary or tertiary interventions in SouthEast Asia.

Proposed e-learning ideas can include programs, training or other initiatives that are secondary/tertiary CVE and are based on experiences in South-East Asia. Examples include a social reintegration program or model for convicted terrorists, deportees or returnees or a training program in a specific economic skill to re-engage those at risk of extremism.

#### Consultation

The e-learning modules that are developed will aim to serve the learning needs of CSOs and other stakeholders across South-East Asia.

To achieve this, proposed ideas should demonstrate some level of consultation undertaken with the community and government. Applications should also highlight how the proposed concept addresses the learning needs and gaps identified by these stakeholders.
